Diving: The diving competition will be held at the CU Student Rec. Center on Saturday, January 24th, from 4:00PM. to 8:30PM. The diving competition will be an eleven dive varsity competition, and a six dive junior varsity competition including the required dive of that week. WARM-UP/START TIMES:

Swimming Prelims: Warm-up 2:30 PM/Start 4:15 PM; Finals: Warm-up 2:00 PM/Start 3:00 PM.
Diving: Warm-up 2:00 PM. Start 4:00PM

FORMAT: The schedule of events will follow the regular high school format. The top 18 swimmers from each event will participate in the finals. The finals for swimming will consist of three heats: a “second consolation” heat for places 13-18, a “consolation” heat for places 7-12; and the “championship” heat for places 1-6.

ENTRIES PER TEAM:

1) Each team may enter four (4) swimmers in each individual event and two (2) relays in each relay event (see Qualifying Times below). Each swimmer is limited to either 2 relays and 2 individual events or 3 relays and 1 individual event. Each team may have 4 divers.

2) Schools have the option of dividing their swimmers into two or more separate “teams”. Each “team” will need their own separate team name, and the entry fees will be assessed as detailed above. Point totals will be kept separate for each “team” and both sets of relays will score.

3) Qualifying Times: In order to shorten the preliminaries, we have set qualifying times for the 500 freestyle, 200 freestyle and 200 individual medley events. The qualifying times in these three events will be (6:38.0) for the 500 free, (2:22.0) for the 200 yard freestyle, and (2:43.0) the 200 individual medley. No qualifying times will be required for the other 5 individual events. Boulder County rules permit 4 swimmers per individual event per team.

USS: USS Swim officials will be present at the meet to validate any qualifying times for USS events. If you have USS swimmers who want their times to be reported to CSI, please provide the following at the meet to the USS Coordinator.: first name, middle initial, last name, birthdate, club and events they plan on swimming. SCORING: Scoring for 18 places as per the 2008-2009 NFHS Rulebook.

AWARDS: Trophies will be given to first and second place teams for 5A & 4A. Ribbons will be awarded. High Point swimmer and High Point freshman will be awarded based upon individual events

ADMISSION: Adults: \$5.00/session Students: \$3.00/session
Heat Sheets will be available at a cost of \$3.00 for preliminaries and \$2.00 for finals.

FACILITIES: Locker rooms will be available. Swimmers are responsible for their own valuables. Swimmers will be in Gym. They need to bring their own blankets, sleeping bags, or chairs. The gym can be cold.
